Afikim Electric Vehicles Australasia warrants its product to be free from defects in materials and workmanship for a period of three (3) years on the frame and three (3) years on the electrical system, from date of purchase. If, within such warranty period, any such product shall be proven defective, such product shall be repaired or replaced at Afikim Electric Vehicles Australasia's option. This warranty does not include any labour or shipping charges incurred in replacement, part installation, or repair of any such product. Afikim Electric Vehicles Australasia's sole obligation and your exclusive remedy under this warranty shall be limited to such repair and/or replacement.

Spare Parts Warranty

Warranty Exclusions
